**Changes in travel reimbursement
in the Czech Republic from
1 January 2021**

Changes in travel reimbursement in the Czech Republic from 1 January 2020

We would like to inform you that by Decree No. 589/2020 Coll. of 21 December 2020 of the Ministry of Labour and Social Affairs of the Czech Republic, with effect from 1 January 2021, there are changes in basic compensation for the purpose of travel expenses reimbursement. The following rates are now valid:

Meal allowance

For each calendar day of business trip, employees are entitled to a meal allowance of:

1. **Business sphere:**
 - a) Min. CZK **91**, if the business trip lasts **5 – 12 hours**,
 - b) Min. CZK **138**, if the business trip lasts **more than 12 hours**, but maximum 18 hours,
 - c) Min. CZK **217**, if the business trip lasts **more than 18 hours**.

2. **State and contributory sphere:**
 - a) CZK **91 – 108**, if the business trip lasts **5 – 12 hours**,
 - b) CZK **138 – 167**, if the business trip lasts **more than 12 hours**, but maximum 18 hours,
 - c) CZK **217 – 259**, if the business trip lasts **more than 18 hours**.

The basic rate for the use of road motor vehicles

The basic rate for 1 km compensation for:

- a) two-wheeled vehicles and tricycles CZK **1.20**,
- b) motor vehicles CZK **4.40**,
- c) wagon, bus, tractor CZK **8.80**.

The average price of fuel

The average price for one litre of fuel under Section 158 (3) of the Labour Code is:

- a) CZK **27.80** for automotive gasoline 95 octane,
- b) CZK **31.50** for automotive gasoline 98 octane,
- c) CZK **27.20** for diesel,
- d) CZK **5** for electric car (for 1kWh).
